## **CERTIFICATE OF LOCATION**

PLACER MINING CLAIM

NOTICE IS HEREBY GIVEN that AMERICAN VANADIUM US INC., a Nevada Corporation whose mailing address is P.O. Box 983, Eureka, Nevada, 89316, located the Dry 4 placer mining claim, more particularly described below, on the 20<sup>th</sup> day of May, 2011.

The claim is approximately 1,320 feet long and 660 feet wide, such that 660 feet are claimed in a Southerly direction from the northern boundary at the NW corner of the claim (monument of location), at which a Notice of Location was duly posted.
