CERTIFICATE OF LOCATION

PLACER MINING CLAIM

NOTICE IS HEREBY GIVEN that **AMERICAN VANADIUM US INC.**, a Nevada Corporation whose mailing address is P.O. Box 983, Eureka, Nevada, 89316, located the **Dry 7** placer mining claim, more particularly described below, on the **20th** day of **May, 2011**.

The claim is approximately 1,320 feet long and 660 feet wide, such that **1,320** feet are claimed in a Southerly direction from the northern boundary at the NW corner of the claim (monument of location), at which a Notice of Location was duly posted. The monument of location upon which the Notice of Location was posted is a wood post measuring at least 1½" x 1½" x 4', set one foot in the ground.

The exterior boundaries of the claim are distinctly marked by four wooden posts measuring at least 1½" x 1½" x 4', set one foot in the ground, one at each corner. The boundaries of the claim are described as follows: Beginning at the NW corner of the claim, which is marked corner Dry 7 NW, from which the SW corner of Section 6, Township 15 North, Range 53 East, MDM bears **West** a distance of **3,300** feet, and bears **South** a distance of **2,640** feet:

thence **660 feet East** to the NE Corner, which is marked corner Dry 7 NE,
thence **1,320 feet South** to the SE Corner, which is marked corner Dry 7 SE,
thence **660 feet West** to the SW Corner, which is marked corner Dry 7 SW,
thence **1,320 feet North** to said corner Dry 7 NW, the point of beginning.

The corners were so marked on the posts with black ink, or were marked on a scribed aluminum tag attached to the post.


The claim is located within the:
