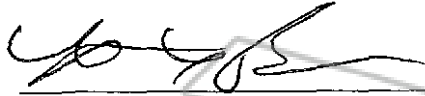
Robert L. Brock, being duly sworn, says:

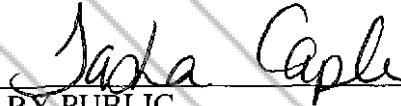

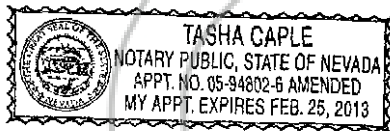
