**AFFIDAVIT AND
NOTICE OF INTENTION TO HOLD
UNPATENTED MINING CLAIMS - RW CLAIM GROUP
FOR THE NEVADA STATE ASSESSMENT YEAR ENDING SEPTEMBER 1, 2011**

The undersigned, being first duly sworn, states under penalty of perjury that the statements herein are true:

1. 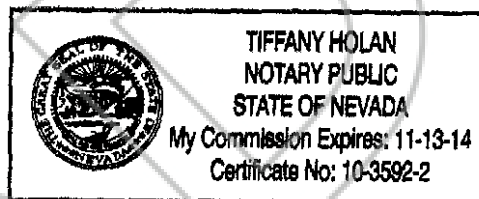
