DISMISS BANKRUPTCY

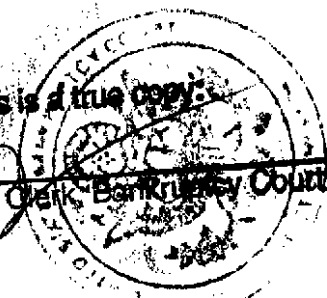
