MEMORANDUM OF FIFTH AMENDMENT TO MINING LEASE AND OPTION TO PURCHASE AGREEMENT

This Memorandum of Fifth Amendment to Mining Lease and Option to Purchase Agreement ("the Fifth Amendment"), dated effective as of October 30, 2011, is by and between **GEORGIA LYNN FARLEY**, widow of **ROBERT L. FARLEY**, of 650 S. Arbor Lane, #206, Meridian, Idaho, 83642, and **CARL A. FARLEY and DONNA L. FARLEY**, husband and wife, of 1335 Arata Way, Ontario, Oregon 97914, (collectively the "Farley's"), on the one hand, and **BARRICK GOLD EXPLORATION INC.**, a Delaware corporation, (successor in interest to Barrick Gold Exploration Inc., an Ohio corporation), whose address is 293 Spruce Road, Elko, Nevada 89801 ("BGEI"), and **NEWMONT USA LIMITED**, d/b in Nevada as **NEWMONT MINING CORPORATION**, a Delaware corporation (successor in interest to Newmont Mining Corporation), whose address is 1655 Mountain City Highway, Elko, Nevada 89801, ("NMC"), (collectively "Lessee").

RECITALS

- A. The Farley's, as lessors and optionors, entered into a Mining Lease and Option to Purchase Agreement, dated effective as of November 4, 1991, with BGEI, as lessee and optionee (the "Agreement"), pertaining to certain real property located in Eureka County, Nevada, which property is more particularly described in Exhibit A attached to and made a part of this Fourth Amendment (the "Property").
- B. BGEI assigned the Agreement to Barrick Goldstrike Mines Inc., ("BGMI"), by an Assignment dated June 30, 1994.

- C. BGMI and Gold Ventures entered into the High Desert and Barrick Gold Venture Agreement, effective May 1, 1994 (the "Venture Agreement"), pursuant to which Gold Ventures acquired an undivided interest in the Agreement.
- D. BGMI assigned a Sixty-Nine percent (69%) interest in the Agreement and Venture Agreement to Gold Ventures by an assignment dated December 18, 1996.
- E. BGMI assigned its remaining Thirty-One percent (31%) interest in the Agreement and Venture Agreement to BGEI by assignment dated December 19, 1996.
- F. Gold Ventures assigned a Twenty-Five percent (25%) interest in the Venture Agreement to NMC by assignment dated October 25, 1996.
- G. Gold Ventures withdrew from the Venture Agreement effective November 27, 2002. Gold Ventures conveyed all of its ownership interest (49.2641 %) to Barrick and Newmont by executing respective Mining Claim Special Warranty Deeds and Assignments in favor of Barrick (61.1% interest), and Newmont (38.9% interest).
- H. Following the assignments by Gold Ventures to BGEI and Newmont, BGEI holds a 61.1004% and Newmont holds a 44.1637% interest in the Agreement and the Venture Agreement.
- I. The Farley's and BGMI/Gold Ventures entered into a First Amendment to Agreement, dated September 1, 1996, extending the term of the Agreement an additional five years, until November 4, 2001. The Farleys's and BGEI, Gold Ventures and NMC entered into the Second Amendment, dated October 30, 2001, extending the term of the Agreement an additional five years, until November 4, 2006. Note, the Third Amendment to the Agreement was inadvertently skipped and never initiated. The Fourth Amendment to the Agreement, dated October 30, 2006, extending the term of the Agreement an additional five years, until November 4, 2011.
- J. The Farley's and Lessee have entered into a Fifth Amendment, dated October 30, 2011. The Fifth Amendment extends the term of the Agreement for an additional five (5) year term, until November 4, 2016.

PURPOSE OF MEMORANDUM

The purpose of this Memorandum of the Fifth Amendment to Mining Lease and Option to Purchase Agreement is for recordation and the notice thereby imparted. This Memorandum does not, in any way, serve to modify the provisions of the Agreement, Venture Agreement or the Fifth Amendment referred to above.
