RECORDER'S STAMP

The Claim is approximately **1500** feet long and **600** feet wide, such that **10** feet are claimed in a **EAST** direction and **1490** feet in the opposite direction from the point of discovery (monument of location), at which the Notice of Location was posted, together with **300** feet on each side of the monument of location and center line of the Claim.
