## **CERTIFICATE OF LOCATION**

LODE MINING CLAIM

NOTICE IS HEREBY GIVEN that AMERICAN VANADIUM US INC., a Nevada corporation whose mailing address is P.O. Box 983, Eureka, Nevada 89316, located the MATT 22 lode mining claim, more particularly described below, on the 29th day of September, 2011.

The claim is approximately 1500 feet long and 600 feet wide, such that 1450 feet are claimed in a West direction and 50 feet in a East direction from the point of discovery (monument of location), at which a Notice of Location was duly posted, together with 300 feet on each side of the monument of location and center line of the claim.
