CERTIFICATE OF LOCATION
LODE MINING CLAIM

NOTICE IS HEREBY GIVEN that **AMERICAN VANADIUM US INC.**, a Nevada corporation whose mailing address is P.O. Box 983, Eureka, Nevada 89316, located the **MATT 22** lode mining claim, more particularly described below, on the **29th** day of **September, 2011**.

The claim is approximately **1500** feet long and **600** feet wide, such that **1450** feet are claimed in a **West** direction and **50** feet in a **East** direction from the point of discovery (monument of location), at which a Notice of Location was duly posted, together with **300** feet on each side of the monument of location and center line of the claim. The monument of location upon which the Notice of Location was posted is a wood post measuring at least $1\frac{1}{2}$ " x $1\frac{1}{2}$ " x 4', set one foot in the ground. The general course of the lode or vein is from the **East to West** direction.

The exterior boundaries of the claim are distinctly marked by four wooden posts measuring at least $1\frac{1}{2}$ " x $1\frac{1}{2}$ " x 4', set one foot in the ground, one at each corner. The boundaries of the claim are described as follows: Beginning at the **SW** corner (Cor. 1) of the claim, which is marked "**MATT 22 SW Cor.**", from which the **SW** corner of Section 36, Township 16 North, Range 52 East, M.D.B.&M. bears **477 feet North and 1088 feet East**:
thence **600 feet North** to the **NW** Corner (Cor. 2), which is marked "**MATT 22 NW Cor.**",
thence **1500 feet East** to the **NE** Corner (Cor. 3), which is marked "**MATT 22 NE Cor.**",
thence **600 feet South** to the **SE** Corner (Cor. 4), which is marked "**MATT 22 SE Cor.**",
thence **1500 feet West** to said Cor. 1, the point of beginning.

The corners were so marked on the posts by scribed metal tags.

The claim is located within the:


SW $\frac{1}{4}$ of Section 31, Township 16 North, Range 53 East
