CERTIFICATE OF LOCATION
LODE MINING CLAIM

NOTICE IS HEREBY GIVEN that **AMERICAN VANADIUM US INC.**, a Nevada corporation whose mailing address is P.O. Box 983, Eureka, Nevada 89316, located the **FLOW 12** lode mining claim, more particularly described below, on the **3rd** day of **December, 2011**.

The claim is approximately **1500** feet long and **600** feet wide, such that **1480** feet are claimed in a **N 46°43' E** direction and **20** feet in a **S 46°43' W** direction from the point of discovery (monument of location), at which a Notice of Location was duly posted, together with **300** feet on each side of the monument of location and center line of the claim. The monument of location upon which the Notice of Location was posted is a wood post measuring at least **1½" x 1½" x 4'**, set one foot in the ground. The general course of the lode or vein is from the **Northeasterly to the Southwesterly** direction.

The exterior boundaries of the claim are distinctly marked by four wooden posts measuring at least **1½" x 1½" x 4'**, set one foot in the ground, one at each corner. The boundaries of the claim are described as follows: Beginning at the **NE** corner (Cor. 1) of the claim, which is marked "**Flow 12 North Cor.**", from which the SW corner of Section 36, Township 16 North, Range 52 East, M.D.B.&M. bears **6472 feet South and 4565 feet East**:

thence **600 feet S 43°30'E** to the **SE** Corner (Cor. 2), which is marked "**Flow 12 East Cor.**",
thence **1500 feet S 46°43'W** to the **SW** Corner (Cor. 3), which is marked "**Flow 12 South Cor.**",
thence **600 feet N 43°30'W** to the **NW** Corner (Cor. 4), which is marked "**Flow 12 West Cor.**",
thence **1500 feet N 46°43'E** to said Cor. 1, the point of beginning.

The corners were so marked on the posts by scribed metal tags.

The claim is located within the:


NE¼ of Section 7, Township 15 North, Range 53 East
