**CERTIFICATE OF LOCATION**  
**LODE MINING CLAIM**

NOTICE IS HEREBY GIVEN that **AMERICAN VANADIUM US INC.**, a Nevada corporation whose mailing address is P.O. Box 983, Eureka, Nevada 89316, located the **AV1103** lode mining claim, more particularly described below, on the **4th** day of **October, 2011**.

The claim is approximately **400** feet long and **400** feet wide, such that **200** feet are claimed in a **North** direction and **200** feet in a **South** direction from the point of discovery (monument of location), at which a Notice of Location was duly posted, together with **200** feet on each side of the monument of location and center line of the claim. The monument of location upon which the Notice of Location was posted is a wood post measuring at least  $1\frac{1}{2}$ " x  $1\frac{1}{2}$ " x 4', set one foot in the ground. The general course of the lode or vein is from the **North to the South** direction.

The exterior boundaries of the claim are distinctly marked by four wooden posts measuring at least  $1\frac{1}{2}$ " x  $1\frac{1}{2}$ " x 4', set one foot in the ground, one at each corner. The boundaries of the claim are described as follows: Beginning at the **NE** corner of the claim, which is marked "**NE Corner AV1103**", from which the SW corner of Section 34, Township 16 North, Range 52 East, M.D.B.&M. bears **S 50°58'52" W a distance of 1087.79 feet:**

thence **400** feet South to the SE corner, which is marked "**SE Corner AV1103**",  
thence **400** feet West to the SW corner, which is marked "**SW Corner AV1103**",  
thence **400** feet North to the NW corner, which is marked "**NW Corner AV1103**",  
thence **400** feet East to the NE corner, the point of beginning.

The corners were so marked on the posts by scribed metal tags.

The claim is located within the:


NE¼ of Section 3, Township 15 North, Range 52 East
