MEMORANDUM OF AMENDMENT TO RIGHT OF WAY OPTION

WHEREAS, Reference is made to that certain unrecorded Right of Way Option dated July 14, 2011 for gas transmission facilities by and between Dean A. Rhoads and Sharon L. Rhoads, trustees of the Dean and Sharon Rhoads Trust, created by instrument dated October 21, 1997, Grantor, and Energy Operations Management, Inc., a California corporation, Grantee, a Memorandum of which is recorded in the Official Records of Elko County, Nevada on August 8, 2011 as Document No. 643579, and a counterpart recorded on September 9, 2011 in the Official Records of Eureka County, Nevada as Document No. 0218525 and covering certain lands as described therein; and

WHEREAS, The parties inadvertently omitted a parcel of land in the legal description and desire to add that parcel in the corrected Exhibits A and B attached hereto; now, therefore, be it

RESOLVED. That. Dean A. Rhoads and Sharon L. Rhoads, trustees of the Dean and Sharon Rhoads Trust, created by instrument dated October 21, 1997, as Grantor, and Energy Operations Management, Inc., a California corporation, as Grantee, hereby amend above the Right of Way Option dated July 14, 2011 to include all those lands described in the attached Exhibit A and depicted on Exhibit B, and Grantor grants to Grantee all of the rights granted in that certain Right of Way Option dated July 14, 2011, as amended, as if all of the lands were originally described in the attached Exhibit A and depicted on Exhibit B.

The provisions hereof shall inure to the benefit of, and be binding on, the respective successors and assigns of the parties hereto.

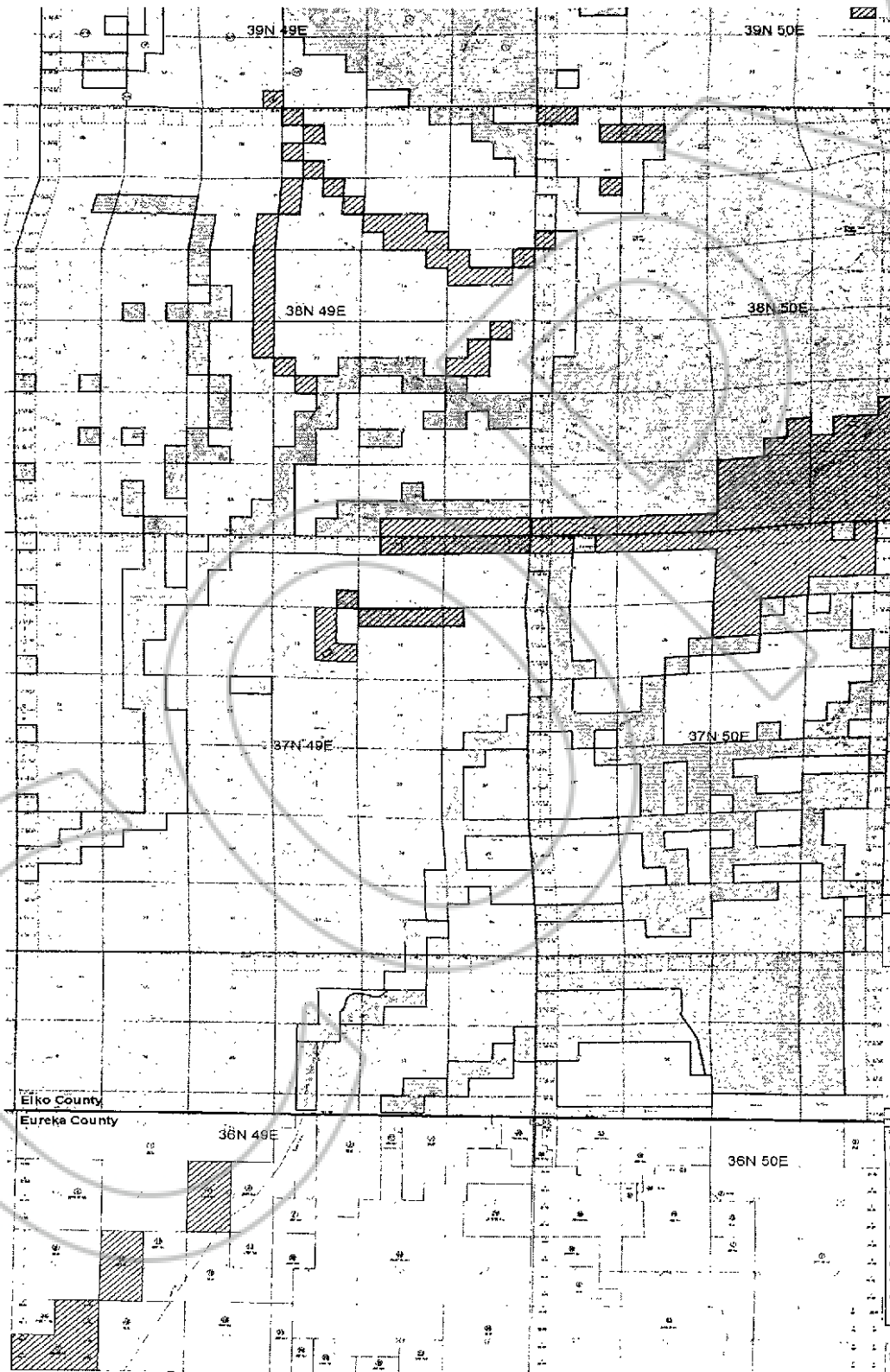

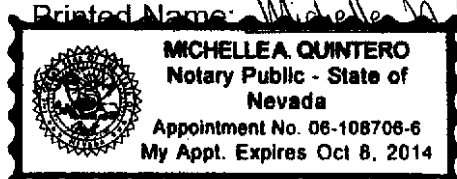
