MEMORANDUM OF WATER RIGHT LEASE

OF WATER RIGHTS LEASE THIS MEMORANDUM , 2012 ("Effective Date") between Gary G. and Melody I. Garaventa, husband and wife, whose address is PO Box 65, Eureka, NV 89316 ("Lessors") and Homestake Mining Company of California, a California corporation, whose address is 136 East South Temple, Suite 1800, Salt Lake City, UT 84111 ("Lessee") shall provide notice that the parties shown above have entered into a Water Rights Lease as of the Effective Date. The pertinent terms of the Water Rights Lease are:

- 1. Lease and Term. (a) Lessors are the owners of Permit 18908, Certificate No. 6468 (the "Water Rights") for irrigation of land located in the same groundwater basin as the Ruby Hill Mine. These water rights are further described in Exhibit A.
 - (b) Lessors are willing to lease the Water Rights to Lessee, and Lessee is willing to lease the Water Rights from Lessors pursuant to the terms and conditions of the Water Rights Lease as summarized herein.
 - (c) Subject to the terms and provisions of this Agreement, Lessors have leased to the Lessee, Lessors' right title and interest in Four Hundred and Forty-Five (445) acre feet of the Water Rights (the "Leased Water") with a pro rata diversion rate of 1.8294 cfs, and hereby reserve two and five hundred seventy six one thousandths (2.576) acre feet with a diversion rate of 0.0106 cfs for Lessors' use from Permit 18908, Certificate No. 6468.
 - (d) This Agreement shall commence on the Effective Date and continue for an initial term of ten (10) years.
 - (e) Lessee may give notice to extend the Water Right Lease for an additional ten year term subject to the terms and conditions provided in the Water Right Lease.

- 2. Modification of Agreement. The Water Right Lease may be amended or varied only by a writing signed by both parties.
- 3. Additional Terms. Additional terms and conditions are contained in the Water Right Lease between parties. This Memorandum of Water Right Lease shall not modify said agreement.
