CERTIFICATE OF LOCATION

LODE MINING CLAIM

NOTICE IS HEREBY GIVEN that JANELLE DIETRICH, a citizen of the United States whose mailing address is 362 Elges Way, Sparks, Nevada 89431-1343, located the BLACK HILL 14-N lode mining claim, more particularly described below, on the 21st day of March, 2012.
