CERTIFICATE OF LOCATION

LODE MINING CLAIM

NOTICE IS HEREBY GIVEN that AMERICAN VANADIUM US INC., a Nevada corporation whose address is P.O. Box 983, Eureka, Nevada, 89316 located the AV1202 lode mining claim, more particularly described below, on the 21st day of March, 2012.
