CERTIFICATE OF LOCATION
LODE MINING CLAIM

NOTICE IS HEREBY GIVEN that **AMERICAN VANADIUM US INC.**, a Nevada corporation whose mailing address is P.O. Box 983, Eureka, Nevada 89316, located the **FLOW 16** lode mining claim, more particularly described below, on the 20th day of **March, 2012**.

The claim is approximately **1500** feet long and **600** feet wide, such that **10** feet are claimed in a **North** direction and **1490** feet in a **South** direction from the point of discovery (monument of location), at which a Notice of Location was duly posted, together with **300** feet on each side of the monument of location and center line of the claim. The monument of location upon which the Notice of Location was posted is a wood post measuring at least $1\frac{1}{2}$ " x $1\frac{1}{2}$ " x 4', set one foot in the ground. The general course of the lode or vein is from the **North to South** direction.

The exterior boundaries of the claim are distinctly marked by four wooden posts measuring at least $1\frac{1}{2}$ " x $1\frac{1}{2}$ " x 4', set one foot in the ground, one at each corner. The boundaries of the claim are described as follows: Beginning at the **NW** corner (Cor. 1) of the claim, which is marked "**NW Corner Flow 16**", from which the **NE** corner of Section 7, Township 15 North, Range 53 East, M.D.B.&M. bears **3863 feet North and 1910 feet West**:

thence **600 feet E** to the **NE** Corner (Cor. 2), which is marked "**NE Corner Flow 16**",
thence **1500 feet S** to the **SE** Corner (Cor. 3), which is marked "**SE Corner Flow 16**",
thence **600 feet W** to the **SW** Corner (Cor. 4), which is marked "**SW Corner Flow 16**",
thence **1500 feet N** to said Cor. 1, the point of beginning.

The corners were so marked on the posts by scribed metal tags.

The claim is located within the:


NE $\frac{1}{4}$ of Section 18, Township 15 North, Range 53 East

SW $\frac{1}{4}$ of Section 7, Township 15 North, Range 53 East
NW $\frac{1}{4}$ of Section 18, Township 15 North, Range 53 East
M.D.B.&M., Eureka County, Nevada.

The boundaries of the claim were defined as required by law within 60 days from the date of posting of the Notice of Location. The work of location consisted of making the claim map as provided in N.R.S. § 517.040.
