Being duly authorized, I make this affidavit on behalf of Homestake Mining Company of California, 460 West 50 North, Suite 500, Salt Lake City, UT 84101

1. 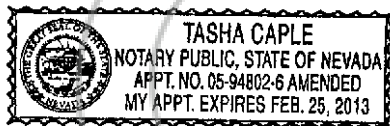
