**CERTIFICATE OF LOCATION**
LODE MINING CLAIM

NOTICE IS HEREBY GIVEN that **AMERICAN VANADIUM US INC.**, a Nevada corporation, whose mailing address is **P.O. Box 983, Eureka, Nevada 89316**, located the **AV1210** lode mining claim on the **4th** day of **September, 2012**, at **4:22 pm** Pacific Daylight Time.

The claim is approximately **1,500** feet long and **600** feet wide, such that **950** feet are claimed in a **North** direction and **550** feet in a **South** direction from the point of discovery (monument of location), at which a Notice of Location was duly posted, together with **300** feet on each side of the monument of location and center line of the claim. The general course of the lode or vein, as near as it may be determined, is **North to South**.

The monument of location upon which the Notice of Location is posted is a wooden post measuring at least **1½" x 1½" x 4'**, set at least one foot in the ground. The exterior boundaries of the claim are distinctly marked by four wooden posts, one at each corner, measuring at least **1½" x 1½" x 4'**, set at least one foot in the ground, and marked with a scribed metal tag. The claim is more particularly described by metes and bounds as follows:

Beginning at the point of discovery (the monument of location), which is approximately **10,112** feet **West**, and **3,989** feet **South** from a natural object or permanent monument, being the **SE Corner of Section 36, Township 16 North, Range 52 East, MDM**, thence **300** feet **West** to the true point of beginning, thence **950** feet **North** to the NW corner (Cor. 4) of the claim, which is marked "**N.W. Corner AV1210**,"

thence **600** feet **East** to the NE Corner (Cor. 1), which is marked "**N.E. Corner AV1210**,"

thence **1,500** feet **South** to the SE Corner (Cor. 2), which is marked "**S.E. Corner AV1210**,"

thence **600** feet **West** to the SW Corner (Cor. 3), which is marked "**S.W. Corner AV1210**,"

thence **550** feet **North** to the true point of beginning.

The claim is located within what will likely be the following section if officially surveyed:

SW¼ of Section 2, Township 15 North, Range 52 East,

Mount Diablo Meridian, Eureka County, Nevada.

The boundaries of the claim were defined as required by law within 60 days from the date of posting of the Notice of Location. The work of location consisted of making the claim map as provided in NRS § 517.040.
