DEED OF FULL RECONVEYANCE





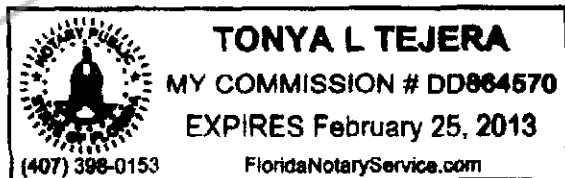
