17 The Court, having reviewed the Master's Recommendation prepared by the Child Support  
18 Hearing Master on August 16, 2012, and,

- 19 (x) No timely objection having been filed hereto.  
20 ( ) The Court, having received the objection(s) thereto, as well as any other papers,  
21 testimony and argument related thereto, and good cause appearing.

22 **IT IS HEREBY ORDERED that the Master's Findings and Recommendations are**  
23 **affirmed and adopted.**

24 **IT IS THEREFORE ORDERED AS FOLLOWS:**

- 25 1. (x) The Obligor is the parent of the following children:

- 1 2. (x) A Judgment is entered against Obligor for child support arrears in the amount of  
2 \$52.84 from January 1, 2007 through May 31, 2012. This shall be paid at \$40.00  
3 a month starting June 1, 2012 until paid in full. A Judgment is entered against  
4 Obligor for interest on child support arrears in the amount of \$548.92 from  
5 January 1, 2007 through May 31, 2012.
- 6 3. (x) The Obligor shall pay \$1,337.03 per month in ongoing support beginning June 1,  
7 2012, with the support raising to \$1,379.03 beginning July 1, 2012 and remaining  
8 at that rate until further order of the Court.

9 **All payments MUST be in the form of a cashier's check or money order ONLY. Effective  
10 August 1, 2000, all child support payments must be payable to State Collection and  
11 Disbursement Unit (SCaDU) and mailed to: SCaDU, P.O. Box 98950, Las Vegas, NV  
12 89193-8950.**

13 **NOTICE: NO CREDIT WILL BE GIVEN FOR PAYMENTS PAID DIRECTLY  
14 TO THE OBLIGEE OR THE CHILDREN.**

15 **Additionally, the Obligor MUST place his/her social security number on each payment.**

16 **Effective January 1, 2004, simple interest will accrue on all unpaid child support balances  
17 for cases with a Nevada controlling order pursuant to NRS 99.040. Interest assessed by a  
18 judgment of the court prior to January 1, 2004 will be enforced.**

19 **A 10% penalty will be assessed on each unpaid installment, or portion thereof, of an  
20 obligation to pay support for a child, pursuant to NRS 125B.095.**

21 **If you pay your child support through income withholding and your full obligation is not  
22 met by the amount withheld by your employer, you are responsible to pay the difference  
23 between your court ordered obligation and the amount withheld by your employer directly  
24 to the state disbursement unit. If you fail to do so you will be subject to the assessment of  
25 penalties and interest.**

26 **YOU MAY AVOID THESE ADDITIONAL COSTS BY MAKING YOUR CURRENT  
27 CHILD SUPPORT PAYMENTS EACH MONTH.**

- 28 4. (x) The Obligor shall provide health insurance, including medical, dental, orthodontic  
and ophthalmological coverage for the children if available through his  
employment at a reasonable cost, including any group health plan(s) under  
ERISA, from the date of this order on and until said children are no longer eligible  
for said coverage, and both parties shall cooperate and provide assistance in  
obtaining payment for health care services. You are required to notify the Child  
Support Enforcement Office when health insurance coverage is available or has  
been terminated.
5. (x) The Obligor shall pay health care expenses, including medical, dental,  
orthodontic, and ophthalmological services for the children as follows: one half



of all costs not covered by insurance, upon being provided by Obligee with adequate documentation/billing regarding said expenses and any EOB or other insurance payment documentation.

- 6. (x) The Obligor shall notify the State Child Support Office or the District Attorney's Child Support Office of any change of address or employment within ten (10) days.
- 7. (x) A wage/income withholding shall be issued starting immediately.
- 8. Pursuant to NRS 125B.145 this Order may be reviewed every three (3) years and is subject to future modifications.
- 9. Unless a stay of this Order is obtained from District Court, all enforcement procedures including, but not limited to wage withholding, garnishment, liens and the attachment of federal income tax returns will be undertaken upon entry of this Order.
- 10. If any determination of paternity in this Order is at variance with the children's birth certificate issued in this state, a new birth certificate is to be issued pursuant to NRS 440.325.
- 11. The parties shall fill out the attached Court Information Sheet and mail or deliver the same to the Nevada State Welfare Division, Child Support Enforcement, 1020 Ruby Vista Drive #101, Elko, Nevada 89801 for filing with the court within ten (10) days from the date of this Order. The parties shall update this form within ten (10) days of it becoming inaccurate.


