The Claim is approximately 1500 feet long and approximately 600 feet wide, such that 1490 feet is claimed in an Easterly direction and 10 feet is claimed in a Westerly direction from the point of discovery (monument of location), at which the Notice of Location is posted, together with 300 feet on each side of the monument of location and centerline of the claim. The general course of the vein and these premises is east and west.
