**CERTIFICATE OF LOCATION**  
**LODE MINING CLAIM**

NOTICE IS HEREBY GIVEN that **AMERICAN VANADIUM US INC.**, a Nevada corporation, whose mailing address is **P.O. Box 983, Eureka, Nevada 89316**, located the **RHYOLITE 10** lode mining claim on the **29th** day of **October, 2012**, at **10:20 am** Pacific Daylight Time.

The claim is approximately **1500** feet long and **600** feet wide, such that **10** feet are claimed in a **S 46° 27' 18" W** direction and **1490** feet in a **N 46° 27' 18" E** direction from the point of discovery (monument of location), at which a Notice of Location was duly posted, together with **300** feet on each side of the monument of location and center line of the claim. The general course of the lode or vein, as near as it may be determined, is **S 46° 27' 18" W to N 46° 27' 18" E** direction.

The monument of location upon which the Notice of Location is posted is a wooden post measuring at least **1½" x 1½" x 4'**, set at least one foot in the ground. The exterior boundaries of the claim are distinctly marked by four wooden posts, one at each corner, measuring at least **1½" x 1½" x 4'**, set at least one foot in the ground, and marked with a scribed metal tag. The claim is more particularly described by metes and bounds as follows:


