CERTIFICATE OF LOCATION

Lode Mining Claim

NOTICE IS HEREBY GIVEN that Barrick Gold Exploration Inc., 293 Spruce Road, Elko, NV 89801, hereby claims under and pursuant to the laws of the State of Nevada and of the laws of the United States of America the following described LODE MINING CLAIM:

The name of the claim is the <u>AV 144</u>.

This claim was located on <u>September 14, 2012</u>, by posting a Location Notice at the discovery monument.
