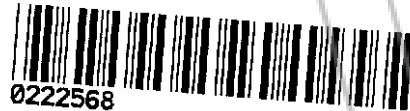

CERTIFICATE OF LOCATION

Lode Mining Claim

NOTICE IS HEREBY GIVEN that **Barrick Gold Exploration Inc.**, 293 Spruce Road, Elko, NV 89801, hereby claims under and pursuant to the laws of the State of Nevada and of the laws of the United States of America the following described LODE MINING CLAIM:

The name of the claim is the AV 263.

This claim was located on September 13, 2012, by posting a Location Notice at the discovery monument.

The length of the claim is 1490 feet in a north direction and 10 feet in the opposite direction from the monument where the Location Notice is posted, and the width is 300 feet on each side of the center of the vein or lode, comprising in all 1500 feet in length and 600 feet in width, and generally following a Northerly-Southerly course.

The exterior boundaries are distinctly marked by four substantial monuments. Each corner monument consists of a 1-1/2" x 1-1/2" x 4' wooden post with aluminum tags attached, scribed with claim name and corner description, set one foot in the ground. The boundaries can be readily traced by beginning at corner No. 1, the NE corner:

thence	<u>1500</u>	feet	<u>south</u>	to the	<u>SE</u>	corner, corner No. 2,
thence	<u>600</u>	feet	<u>west</u>	to the	<u>SW</u>	corner, corner No. 3,
thence	<u>1500</u>	feet	<u>north</u>	to the	<u>NW</u>	corner, corner No. 4,
thence	<u>600</u>	feet	<u>east</u>	to the	<u>NE</u>	corner, corner No. 1, the point of beginning.

Said claim is located in the:

NE 1/4 of Section 6, T 18 N, R 51 E, M.D.M.
SE 1/4 of Section 31, T 19 N, R 51 E, M.D.M.
M.D.M. Eureka County, State of Nevada.
