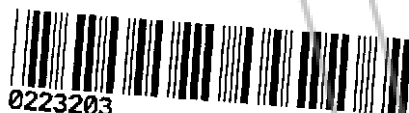

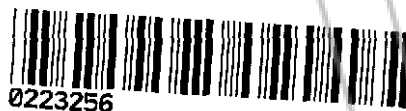

This claim was located on October 16, 2012, by posting a Location Notice at the discovery monument.
