LIMITED POWER OF ATTORNEY

KNOW ALL MEN BY THESE PRESENTS: That Wells Fargo Bank N.A., has made, constituted and appointed, and by these presents does make, constitute and appoint Tim Bargaquast, Seth Ott, Earl Hopida, Janeth Salas, David Balmos, Reina Isip, Vanessa Sisk, Oscar Figueroa, Mauro Guzman, and Stephanie Fuentes, authorized signors of the firm of McCarthy & Holthus, LLP, 1770 Fourth Ave., San Diego, CA 92101, individually and not jointly, its true and lawful attorney in fact for, and in its name, place and stead, and for its use and benefit, for every act customarily and reasonably necessary and appropriate for:
