## **CERTIFICATE OF LOCATION** LODE MINING CLAIM

NOTICE IS HEREBY GIVEN that AMERICAN VANADIUM US INC., a Nevada corporation, whose mailing address is P.O. Box 983, Eureka, Nevada 89316, located the AV12064 lode mining claim on the 13<sup>th</sup> day of November, 2012.
