CERTIFICATE OF LOCATION LODE MINING CLAIM

NOTICE IS HEREBY GIVEN that AMERICAN VANADIUM US INC., a Nevada corporation, whose mailing address is P.O. Box 983, Eureka, Nevada 89316, located the AV12068 lode mining claim on the 13th day of November, 2012.

The claim is approximately 1,500 feet long and 600 feet wide, such that 20 feet are claimed in a East direction and 1480 feet in a West direction from the point of discovery (monument of location), at which a Notice of Location was duly posted, together with 300 feet on each side of the monument of location and center line of the claim. The general course of the lode or vein, as near as it may be determined, is East to West.
