CERTIFICATE OF LOCATION LODE MINING CLAIM

NOTICE IS HEREBY GIVEN that AMERICAN VANADIUM US INC., a Nevada corporation, whose mailing address is P.O. Box 983, Eureka, Nevada 89316, located the AV12095 lode mining claim on the 17th day of November, 2012.

The claim is approximately 200 feet long and 200 feet wide, such that 20 feet are claimed in a S 44° 52' 39" E direction and 180 feet in a N 44° 52' 39" W direction from the point of discovery (monument of location), at which a Notice of Location was duly posted, together with 100 feet on each side of the monument of location and center line of the claim. The general course of the lode or vein, as near as it may be determined, is S 44° 52' 39" E to N 44° 52' 39" W.

The monument of location upon which the Notice of Location is posted is a wooden post measuring at least 11/2" x 11/2" x 4', set at least one foot in the ground. thence 200 feet S 44° 52' 39" E to the SE Corner (Cor. 2), which is marked "SE COR AV12095," thence 200 feet S 45° 7' 21" W to the SW Corner (Cor. 3), which is marked "SW COR AV12095," theree 200 feet N 44° 52' 39" W to the NW Corner (Cor. 4), which is marked "NW COR AV12095," thence 100 feet N 45° 7' 21" E to the true point of beginning.

The claim is located within what will likely be the following sections if officially surveyed: SE¼ of Section 31, Township 16 North, Range 53 East, Mount Diablo Meridian, Eureka County, Nevada.
