CERTIFICATE OF LOCATION LODE MINING CLAIM

NOTICE IS HEREBY GIVEN that AMERICAN VANADIUM US INC., a Nevada corporation, whose mailing address is P.O. Box 983, Eureka, Nevada 89316, located the AV12108 lode mining claim on the 17th day of November, 2012.

The claim is approximately 1,500 feet long and 600 feet wide, such that 20 feet are claimed in a N 44° 52' 39" W direction and 1480 feet in a S 44° 52' 39" E direction from the point of discovery (monument of location), at which a Notice of Location was duly posted, together with 300 feet on each side of the monument of location and center line of the claim. The general course of the lode or vein, as near as it may be determined, is N 44° 52' 39" W to S 44° 52' 39" \mathbf{E} .

thence 1500 feet S 44° 52' 39" E to the SE Corner (Cor. 2), which is marked "SE COR AV12108," thence 600 feet S 45° 7' 21" W to the SW Corner (Cor. 3), which is marked "SW COR AV12108," thence 1,500 feet N 44° 52' 39" W to the NW Corner (Cor. 4), which is marked "NW COR AV12108," thence 300 feet N 45° 7' 21" E to the true point of beginning.
