CERTIFICATE OF LOCATION LODE MINING CLAIM

NOTICE IS HEREBY GIVEN that AMERICAN VANADIUM US INC., a Nevada corporation, whose mailing address is P.O. Box 983, Eureka, Nevada 89316, located the AV12132 lode mining claim on the 29th day of November, 2012.

The claim is approximately 1,030.85 feet long and 600 feet wide, such that 20 feet are claimed in a S 44° 52' 39" E direction and 1010.85 feet in a N 44° 52' 39" W direction from the point of discovery (monument of location), at which a Notice of Location was duly posted, together with 300 feet on each side of the monument of location and center line of the claim.
