CERTIFICATE OF LOCATION LODE MINING CLAIM

NOTICE IS HEREBY GIVEN that AMERICAN VANADIUM US INC., a Nevada corporation, whose mailing address is P.O. Box 983, Eureka, Nevada 89316, located the AV12192 lode mining claim on the 27th day of November, 2012.

The claim is approximately 900 feet long and 600 feet wide, such that 20 feet are claimed in a S 45° 7' 21" W direction and 879.82 feet in a N 45° 7' 21" E direction from the point of discovery (monument of location), at which a Notice of Location was duly posted, together with 300 feet on each side of the monument of location and center line of the claim. The general course of the lode or vein, as near as it may be determined, is S 45° 7' 21" W to N 45° 7' 21" E.

thence 899.82 feet S 45° 7' 21" W to the SE Corner (Cor. 2), which is marked "SE COR AV12192," thence 600 feet N 44° 52' 39" W to the SW Corner (Cor. 3), which is marked "SW COR AV12192," thence 900 feet N 45° 7' 21" E to the NW Corner (Cor. 4), which is marked "NW COR AV12192," thence 300 feet S 44° 52' 39" E to the true point of beginning.

The claim is located within what will likely be the following sections if officially surveyed:
