Agreement for Real Estate

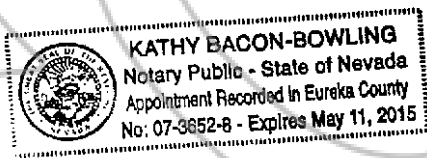
- 1) Roland and LeAnna Good agree to buy the property known as 161 South Spring Street from Linda Wilson for 42,000.00 minus the taxes due.
