MINERAL DEED

THIS INDENTURE is made and entered into this 18 day of February, 2008, by and between **JOHN W. MARVEL**, Trustee of The John W. Marvel Family Trust, on behalf of both Grantors of said Trust, "Grantor"; and **SHARON M. ANDREASEN**, a married woman as her sole and separate property, **JOHN E. MARVEL**, an unmarried man, and **MICHELLE SLAGLE**, a married woman as her sole and separate property, "Grantees."

WITNESSETH:

That the said Grantor, for good and valuable consideration given by the Grantees, the receipt of which is hereby acknowledged, does by these presents, grant, bargain, sell and convey, unto the said Grantees, as tenants-in-common in equal shares, and their heirs, executors, administrators, successors and assigns, all of Grantor's right, title, interest and estate in and to the mineral estate of all that certain property situate, lying and being in the Counties of Elko, Lander, Eureka, Humboldt and Pershing, State of Nevada, more particularly described on Exhibit "A" attached hereto, made a part hereof and incorporated herein by this reference.

SUBJECT TO all covenants, conditions, restrictions, exceptions, easements, rights of way, reservations and rights, and other matters evidenced by documents of record.
