5 been duly served with a copy of the Summons and Complaint in this
6 action as required and directed by law more than twenty (20) days
7 prior hereto by publication, mailing, and posting.

8 3. The above-named Defendants have not appeared herein
9 by answer, motion or other belief.

10 4. The time for the Defendants to appear, answer, move
11 or file any pleading has expired.

12 5. The Summons and Complaint have been duly posted as
13 required by NRS 40.100. A copy of the Declaration of Posting of
14 Summons and Complaint to Quiet Title was filed herein on December
