PARTIAL RELEASE

THIS PARTIAL RELEASE (this "Instrument"), dated as of February 27, 2013, is from U.S. BANK NATIONAL ASSOCIATION, a national banking association, in its capacity as administrative agent ("Secured Party"), with an address at 950 Seventeenth Street, DN-CO-T8E, Denver, Colorado 80202, and DARIA MAHONEY, as trustee ("Trustee"), with an address at 950 Seventeenth Street, DN-CO-T8E, Denver, Colorado 80202, to RESOURCE LEGACY INVESTMENTS, LLC, a Colorado limited liability company ("Mortgagor"), a/k/a RESOURCE LEGACY INVESTMENTS, L.L.C., with an address at 601 Corporate Circle, Golden, Colorado 80401.

RECITALS

A. Mortgagor executed and delivered to Secured Party and Trustee a Mortgage, Deed of Trust, Security Agreement, Assignment, Financing Statement and Fixture Filing dated as of February 14, 2012 (the "Deed of Trust"), the terms and provisions of which are incorporated herein by reference. Capitalized terms used herein without definition shall have the same meanings as set forth in the Deed of Trust. The Deed of Trust was filed and recorded as follows:

B. In connection with an assignment being made by Mortgagor, the parties desire that the Deed of Trust be partially released, INsofar AND ONLY INsofar as it covers the following (the "Released Interest"): an undivided one percent of Mortgagor's present right, title and interest in and to: (1) the lands described on Exhibit "A" attached hereto and made a part hereof, (2) any and all wells, leases and other rights and interests on or relating to such lands, and (3) the accounts, general intangibles, instruments, inventory, contract rights, equipment, proceeds and other real and personal property included in the description of the Collateral contained in the Mortgage, INsofar AND ONLY INsofar as they relate to such lands.

C. Notwithstanding anything to the contrary contained herein, this Instrument shall not affect the undivided 99-percent of its right, title and interest prior to the above-described assignment that Mortgagor continues to own in and to such lands, wells, leases and other property, rights and interests (the "Retained Interest").

In consideration of Ten Dollars and other good and valuable consideration, the receipt and sufficiency of which are hereby acknowledged, Secured Party and Trustee do hereby remise, release, discharge and forever quitclaim to Mortgagor, its successors and assigns, all of the right, title and interest that Secured Party and Trustee may have under the Deed of Trust, INSOFAR AND ONLY INSOFAR as the Deed of Trust covers and relates to the Released Interest, reserving unto Secured Party and Trustee all of their rights and interests under the Deed of Trust in and to the Retained Interest.
