MEMORANDUM OF AMENDMENT TO SURFACE FACILITY AND RIGHT OF WAY AGREEMENT

For and in consideration of the sum of One Dollar and other valuable consideration to the undersigned, the receipt whereof is hereby acknowledged, Barrick Goldstrike Mines, Inc. hereinafter called Grantor, and Prospector Pipeline Company, a Nevada corporation, hereinafter called Grantee, hereby amend that certain Surface Facility and Right of Way Agreement dated July 13, 2012, by and between Grantor and Grantee, a Memorandum of Surface Facility and Right of Way Agreement of which was recorded October 15, 2012 as Document No. 0221699 in the Official Records of Eureka County, Nevada, according to the terms and conditions of that certain Amendment to Surface Facility and Right of Way Agreement of even date between the parties hereto, covering the lands described herein, and said Amendment to Surface Facility and Right of Way Agreement are hereby incorporated by reference with the same force and effect as though herein set forth at length; and

For the same consideration, Grantor hereby grants, leases, lets and demises, without warranty of title, that certain property described on Exhibit "A" and shown on Exhibit "B" for Grantee's pipeline(s) rights of way and use as a surface facility site for the purposes and terms and conditions, together with the right of ingress and egress to and from the surface facility site, as set forth in the above unrecorded Amendment to Surface Facility and Right of Way Agreement of even date.

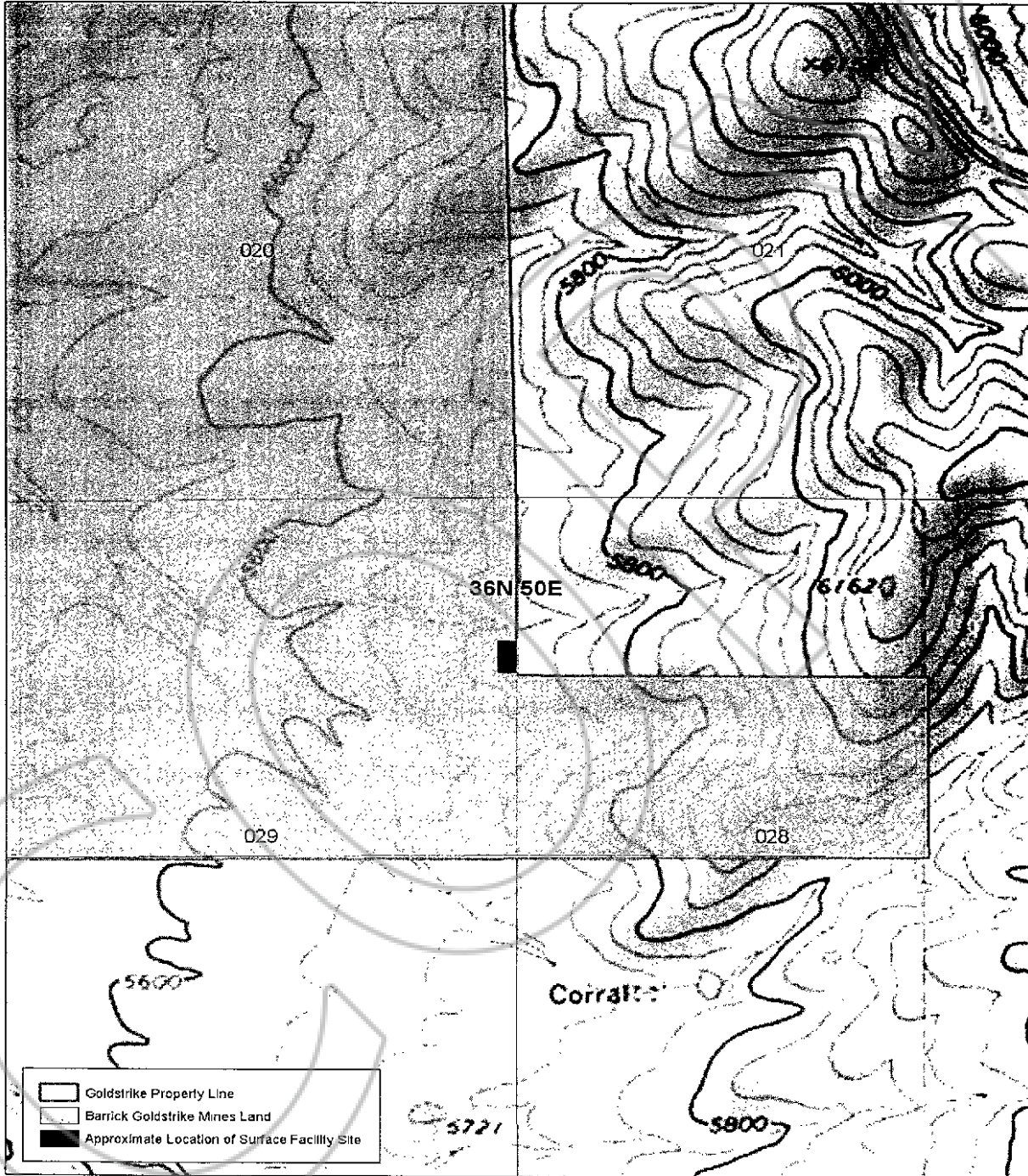
