**CERTIFICATE OF LOCATION**

Lode Mining Claim

NOTICE IS HEREBY GIVEN that Nevada Trend Exploration  
P.O. Box 999, Delta, Utah 84624, hereby claims under and pursuant to  
the laws of the State of Nevada and of the laws of the United States of America  
the following described LODE MINING CLAIM:

The name of the claim is the AGATE 86.  
This claim was located on 1/30/2013, by posting a Location Notice at the discovery monument.

The length of the claim is 20 feet in a South direction and 1480 feet in the opposite direction  
from the monument where the Location Notice is posted, and the width is 300 feet on each side of the center of  
the vein or lode, comprising in all 1500 feet in length and 600 feet in width, and generally following a  
North to South course.

The exterior boundaries are distinctly marked by four substantial monuments. Each corner monument  
consists of a 1-1/2" x 1-1/2" x 4' wooden post with aluminum tags attached, scribed with claim name and corner  
description, set one foot in the ground. The boundaries can be readily traced by beginning at corner No. 1, the  
NE corner:

thence	<u>1500</u>	feet	<u>south</u>	to the	<u>SE</u>	corner, corner No. 2,
thence	<u>600</u>	feet	<u>west</u>	to the	<u>SW</u>	corner, corner No. 3,
thence	<u>1500</u>	feet	<u>north</u>	to the	<u>NW</u>	corner, corner No. 4,
thence	<u>600</u>	feet	<u>east</u>	to the	<u>NE</u>	corner, corner No. 1, the point of beginning.


