MEMORANDUM OF SURFACE LEASE AND AGREEMENT

MEMORANDUM OF SURFACE LEASE AND AGREEMENT

DESCRIPTION OF PROPERTY

A parcel of land located within Government Lots 2 and 3 of Section 2, Township 34 N., Range 51 E., M.D.M., Eureka County, Nevada, bounded by existing fence lines, being more particularly described as follows:

Beginning at the most Easterly corner of the Property, an existing two-way fence corner from which the N¹/₄ Corner of said Section 2 bears approximately N 82°24' W, 697 feet;

Thence S 31°45'06" W, 1002 feet along an existing barbed wire fence to a two-way fence corner;

Thence N 57°20'42" W, 923 feet along an existing barbed wire fence to a three-way fence corner;

Thence N 34°07'15" E, 526 feet along an existing barbed wire fence to a two-way fence corner:

Thence N 89°40'54" E, 900 feet along an existing barbed wire fence to a two-way fence corner;

Thence S 51°40′24″ E, 139.40 feet along an existing barbed wire fence to the said point of beginning at the most Easterly corner of the Property, containing 16.83 Acres, more or less.

This Property is a portion of Eureka County Assessor's Parcel Number 004-190-26. Reference is hereby made to Exhibit B, Map of Property, attached hereto and made a part hereof.

The Property also includes the following described access and area for the purpose of installing, repairing, maintaining and operating, for the life of the Agreement, a water well and water pipeline described as follows:
