That whereas, the Eureka County Treasurer and Tax Receiver of the County of Eureka, State of Nevada, after giving due notice in the manner and form prescribed by N.R.S. 361.565 did on the 26<sup>th</sup> day of **June, 2008**, issue an updated certificate authorizing the County Treasurer and Trustee, as Trustee for the State of Nevada and County of Eureka, to hold the property hereinafter described for the period prescribed by law for redemption of property for unpaid taxes, which said property had been assessed by the Assessor of Eureka County, Nevada in and to the name of **TOLLESON, FRANK V. & MARY L.** as Roll No. **004151** for the fiscal year **2007/ 2008** and

Whereas, **TOLLESON, FRANK V. & MARY L.** has tendered to the Eureka County Treasurer the amount of the taxes, costs, penalties and interest legally chargeable against said property, as set forth in subsection 4 of N.R.S. 361.570, together with interest at the rate of 10 percent per annum until the time of reconveyance, and has requested the reconveyance of said property, and

Whereas, there has been no public notice of sale of such property by the County Treasurer prior to the request of reconveyance.

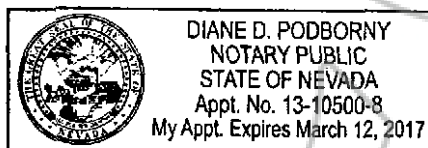
