AMENDMENT OF OIL AND GAS LEASE

THIS AMENDMENT OF OIL AND GAS LEASE (this "Amendment"), dated as of May 13, 2013, is between SLAGOWSKI RANCHES, INC., a Nevada corporation ("Lessor"), Pine Valley Route, Carlin, Nevada 89822, and GRANT CANYON OIL & GAS, LLC, a Colorado limited liability company ("GCOG"), 717 Seventeenth Street, Suite 1400, Denver, Colorado 80202.

RECITALS

- A. Lessor executed and delivered to GCOG an Oil and Gas Lease dated December 1, 2012 (the "Lease"), filed and recorded on January 18, 2013, under Document #0223662, Book 546, Page 322 of the Official Public Records of Eureka County, Nevada.
- B. Lessor and GCOG have noticed certain scrivener's errors included on the Addendum attached to the Lease (the "Addendum").
- C. Lessor and GCOG desire that this Amendment be executed and delivered in order to correct the above-referenced scrivener's errors.

AGREEMENT

In consideration of Ten Dollars and other good and valuable consideration, the receipt and sufficiency of which are hereby acknowledged, Lessor and GCOG hereby agree as follows:

- 1. Lease Amendment. Effective as of the date hereof, the Lease shall be amended as follows:
- (a) The following shall be substituted for Section A-8 on page 2 of the Addendum:
 - A-8 If any lien, encumbrance or security interest is filed against any of the real or personal property of SLAGOWSKI RANCHES, INC. caused or incurred by GCOG, then GCOG shall, within thirty (30) days after such filing, remove the same from the property of SLAGOWSKI RANCHES, GCOG shall provide to SLAGOWSKI RANCHES, INC seven (7) days advance written notice of all construction, repairs (other than repairs of an emergency nature), drilling and other activities GCOG intends to do or cause to be done which could result in a mechanic's or materialmen's lien being filed against SLAGOWSKI RANCHES, INC. s property so that SLAGOWSKI RANCHES, INC. can timely file a written Notice of Non-Responsibility pursuant to N.R.S. 108.234.
- (b) In line 3 of Section A-13 on page 3 of the Addendum, "than" shall be substituted for "that".

- (c) In line 5 of Section A-14 on page 3 of the Addendum, "now" shall be substituted for "not".
- (d) The second and third sentences of Section A-19 on page 5 of the Addendum shall be deleted and the following shall be substituted therefor:

This lease will terminate at the end of the Primary Term unless extended beyond the Primary Term in accordance with the other provisions of this lease.

If a well or wells are in production at the time of expiration of this lease, the surface area devoted to the well site and related equipment and facilities will be no more than five (5) acres per well and will be subject to the terms of this lease.

- (e) In line 2 of Section A-22 on page 5 of the Addendum, "Corporation" shall be deleted.
- 2. Lease Ratification. Each of Lessor and GCOG hereby:
 (a) acknowledges the terms of this Amendment; (b) ratifies and
 affirms its obligations under the Lease, as amended hereby;
 (c) acknowledges, renews and extends its continued obligation to
 perform its duties under the Lease, as amended hereby; and
 (d) agrees that the Lease remains in full force and effect in
 accordance with its terms, as amended hereby.
