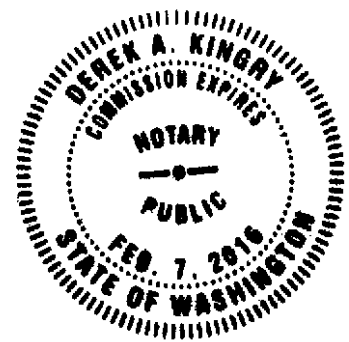
The Grantor will defend the right and title to the real estate described above against claims against the Grantee arising from, under or through the Grantor only.
