The undersigned, being of lawful age and first duly sworn, deposes and states as follows:

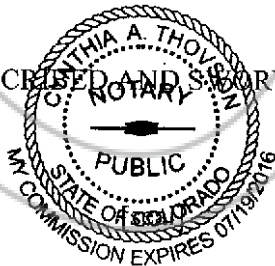
1. I am authorized to make this Affidavit as an agent of the owner of the 7 unpatented mining claims that are the subject of this Affidavit.
