3. The Owner intends to hold the claims for the assessment years ending on September 1, 2013, and September 1, 2014.

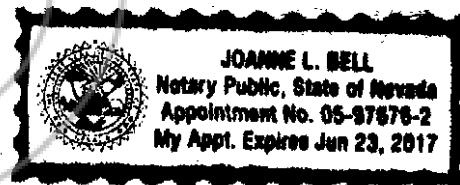
