The Claim is approximately 1500 feet long and 600 feet wide, such that 20 feet are claimed in a
North direction and 1480 in the opposite direction from the point of discovery (monument of
location), at which the Notice of Location was posted, together with 300 feet on each side of the monument of
location and center line of the Claim. The general course of the lode or vein is from the North to the South
direction.

The number, location and markings on each corner monument are as follows:

The exterior boundaries are distinctly marked by four substantial monuments. Each corner monument consists of
2"x2"x4' wooden post with aluminum tags attached, scribed with claim name and corner description set one foot in
the ground. The boundaries can be readily traced by beginning at corner No. 1, the northeast corner:

- thence: 1500 feet S to the SE corner, corner No. 2
- thence: 600 feet W to the SW corner, corner No. 3
- thence: 1500 feet N to the NW corner, corner No. 4
- thence: 600 feet E to the NE corner, corner No. 1

The NE Corner (Cor. No. 1) of this claim lies approximately 8000 feet East and 100 feet North
from the NE Corner of Section 32, T. 19 N, R. 53 E M.D.B.M.
