

RATIFICATION OF MINERAL LEASE AGREEMENT

THIS RATIFICATION OF MINERAL LEASE AGREEMENT ("Ratification") is made as of the 1st day of March, 2011 ("Effective Date") by and between JANELLE DIETRICH, a widow whose address is 362 Eiges Way, Sparks, Nevada 89431-1343 ("Owner"), and AMERICAN VANADIUM US INC., a Nevada corporation whose address for purposes of this Ratification is Attn: Alan Branham, 2778 Spokane Creek Road, East Helena, Montana 59635 ("Lessee").

RECITALS

- A Effective as of March 1, 2006, Owner, together with Kenneth Campbell and Jacqualeene Campbell, as lessors, entered into a Mineral Lease Agreement with Alan David Branham as lessee (the "Lease"). A memorandum of the Lease was recorded in the official records of Eureka County as File No. 204440 in Book 434 at page 349. The Lease covered the unpatented mining claims described in Exhibit A hereto, including any amendments or relocations thereof and all ores, minerals, surface and mineral rights and all water rights and improvements, easements, licenses, rights-of-way, permits and other interests appurtenant thereto (the "Original Claims").
- B. Effective as of May 1, 2006, Alan David Branham, as lessee, assigned all of his rights, title and interest in and to the Lease and the Original Claims to RMP Resources Corp., a Nevada corporation, by virtue of an Assignment recorded in the official records of Eureka County as File No. 204750 in Book 436 at page 116.
- C. Effective as of December 17, 2010, RMP Resources Corp. changed its corporate name to American Vanadium US Inc.
- D. Effective as of February 20, 2011, Kenneth Campbell and Jacqualeene Campbell conveyed to Janelle Dietrich, a widow, all of their rights, title and interest in and to the Original Claims and assigned to Janelle Dietrich all of their rights, title and interest under the Lease, by

- E. Thereafter, Janelle Dietrich, as the sole owner of the Original Claims, abandoned all of the Original Claims by virtue of a Notice of Abandonment of Mining Claims dated February 22, 2011 but effective as of the dates and times set forth therein, which notice is recorded in the official records of Eureka County as Document No. 0216805 in Book 512 at page 315, in order to replace the Original Claims with new claims.
- F. On February 21-24, 2011, Janelle Dietrich located new mining claims (the "Replacement Claims") to replace the Original Claims. The Replacement Claims, which are described in Exhibit B hereto, cover substantially the same ground as the Original Claims covered. The work of locating the Replacement Claims was conducted by American Vanadium US Inc., as lessee, on behalf of the lessor, Janelle Dietrich, as authorized by Section 1.H of the Lease.
- G. Janelle Dietrich, as lessor, and American Vanadium US Inc., as lessee, desire to confirm in this Ratification that the Lease remains in full force and effect and in good standing, covering now the Replacement Claims instead of the Original Claims, and to provide public notice of such facts through the execution and recordation of this Ratification.

NOW, THEREFORE, in consideration of the mutual covenants set forth herein and set forth in the Lease, and for other good and valuable consideration, the adequacy and receipt of which are hereby acknowledged, the parties hereto, incorporating the Recitals set forth above, agree as follows:

- Ratification of Lesse. The parties affirm and ratify the ongoing existence and good standing of the Lesse without interruption in the term or effectiveness thereof, and acknowledge that the Lesse now covers the Replacement Claims rather than the Original Claims.
- Multiple Counterparts. This document may be executed in multiple counterparts
 and all counterparts taken together shall be deemed to constitute one and the same instrument.




