rendered in favor of EASY LOANS CORP. and against MICHELE MICHAELS in the amount of five thousand six hundred eighty one dollars and ten cents (\$5,681.10). This amount represents the unpaid principal balance owing EASY LOANS CORP. Plaintiff waives the option to request repayment of pre-judgment interest. Interest shall accrue on the unpaid principal balance at the statutory rate of 5.25% from the date of the entry of the Judgment by Default forward.

IT IS FURTHER ORDERED, ADJUDGED, AND DECREED, that Judgment is also rendered in favor of EASY LOANS CORP, and against MICHELE MICHAELS that Plaintiff shall incur additional damages in the form of future accrued interest from the date of the entry of the Judgment by Default forward on the unpaid principal balance of the Contract. These damages shall continue to accrue interest on the unpaid principal balance calculated at the statutory rate of 5.25% per annum, which amount currently constitutes the sum of \$0.81 per diem.

This amount represents the reasonable attorney's fees incurred by EASY LOANS CORP, as a result of this litigation.

IT IS FURTHER ORDERED, ADJUDGED, AND DECREED, that Judgment is also rendered in favor of EASY LOANS CORP, and against MICHELE MICHAELS in the additional amount of one hundred forty three dollars and zero cents (\$143.00). This amount represents the costs incurred by EASY LOANS CORP, as a result of this litigation.
