**CORRECTED AND RESTATED
WATER RIGHTS QUITCLAIM DEED**

THIS CORRECTED AND RESTATED WATER RIGHTS QUITCLAIM DEED is
entered into this 15TH day of November, 2013, correcting and restating a previous Water
Rights Quitclaim Deed between JOHN B. MINOLETTI and NANCY M. MINOLETTI, identified
therein as JOHN and NANCY MINOLETTI, hereinafter referred to as "Grantor," and EUREKA
COUNTY, a political subdivision of the State of Nevada, hereinafter referred to as "Grantee."

WITNESSETH:

WHEREAS, Grantor, identified therein as JOHN and NANCY MINOLETTI, executed
a document entitled "Water Rights Quitclaim Deed" on or about the 14th day of May, 2013, and
recorded in the Official Records of Eureka County Recorder's Office on June 11, 2013, as
Document No. 0224434, to Grantee;

WHEREAS, Grantor mis-identified those certain water rights known as Nevada State Engineer's Certificate No. 6942 (Permit No. 20565), as Nevada State Engineer's Certificate No. 20565 (Permit No. 6942) in Document No. 0224434, recorded in the Official Records of Eureka County Recorder's Office on June 11, 2013;

WHEREAS, Grantor wishes and hereby does correct the name of Grantor on Document No. 0224434 on file with the Eureka County Recorder's Office to properly read as "JOHN B. MINOLETTI and NANCY M. MINOLETTI";

WHEREAS, Grantor wishes and hereby does correct the numbers for the Nevada State Engineer's Certificate No. and Permit No. on Document No. 0224434 to properly read as "Nevada State Engineer's Certificate No. 6942 (Permit No. 20565); and

NOW, THEREFORE, Grantor hereby restates and corrects the conveyance of the hereinbelow described water rights to Grantee as follows:

That the GRANTOR, in consideration of the sum of Ten Dollars (\$10.00), lawful money of the United States, and other good and valuable consideration to it in hand paid by the GRANTEE, the receipt whereof is hereby acknowledged, does by these presents quit claim to the GRANTEE, and to its heirs, successors and assigns forever, such right, title and interest held by the GRANTOR in and to 2 acre feet annually of those certain water rights known as Nevada State Engineer's Certificate No. 6942 (Permit No. 20565), at a diversion rate of 0.023, with a permitted place of use at Parcel #1 of map file #212715, T20N, R53E, Section 32. The 2 acre feet annually transferred herein are to be appurtenant to the real property identified as Assessor's Parcel Number 007-340-28 and more particularly described in Exhibit "1" attached hereto and



incorporated herein by this reference.

TOGETHER WITH all and singular the tenements, hereditaments, and appurtenances thereunto belonging or in anywise appertaining, and the reversion and reversions, remainder or remainders, rents, issues, and profit thereof.

TO HAVE AND TO HOLD all and singular the premises, together with the appurtenances, unto the said GRANTEE and to its heirs, successors and assigns forever.

IN WITNESS WHEREOF, the said Grantors have executed this Corrected and Restated Water Rights Quitclaim Deed as of the day and year first above written but made effective May 14, 2013, the date of the original Water Rights Quitclaim Deed that this conveyance hereby corrects and restates.


