**AMENDED CERTIFICATE OF LOCATION**  
**LODE MINING CLAIM**

This document amends the original certificate of location as filed in Eureka County, document number **216806** at Book **512**, Page **318**, and with the Nevada BLM (NMC1038872). This document is being filed to correct the aliquot parts in which the claim is located.

NOTICE IS HEREBY GIVEN that **JANELLE DIETRICH**, a citizen of the United States whose mailing address is 362 Elges Way, Sparks, Nevada 89431-1343, located the **BLACK HILL 1-N** lode mining claim, more particularly described below, on the **23rd** day of **February, 2011** at **9:44 o'clock AM**.

The claim is approximately **1500** feet long and **560.36** feet wide, such that **200** feet are claimed in a **S 44°38'0" E** direction and **1300** feet in a **N 44°38'0" W** direction from the point of discovery (monument of location), at which a Notice of Location was duly posted, together with **280.18** feet on each side of the monument of location and center line of the claim. The monument of location upon which the Notice of Location was posted is a wood post measuring at least **1½" x 1½" x 4'**, set one foot in the ground. The general course of the lode or vein is from the **Southeasterly to Northwesterly** direction.

The exterior boundaries of the claim are distinctly marked by four wooden posts measuring at least **1½" x 1½" x 4'**, set one foot in the ground, one at each corner. The boundaries of the claim are described as follows: Beginning at the **NE** corner of the claim, which is marked corner 1, from which the **SE** corner of Section 36, Township 16 North, Range 52 East, M.D.B.&M. bears **N 82° 54' 34" E** a distance of **8647.02** feet:

thence **565** feet in a **S 52° 43' 00" W** direction to the **SE** Corner, which is marked corner 2,  
thence **1500** feet in a **N 44° 38' 00" W** direction to the **SW** Corner, which is marked corner 3,  
thence **565** feet in a **N 52° 43' 00" E** direction to the **NW** Corner, which is marked corner 4,  
thence **1500** feet in a **S 44° 38' 00" E** direction to said corner 1, the point of beginning.

The corners were so marked on the posts with black ink.

The claim is located within the:


NW¼ quarter of Section 2, Township 15 North, Range 52 East  
SW¼ quarter of Section 35, Township 16 North, Range 52 East  
M.D.B.&M., Eureka County, Nevada.

The boundaries of the claim were defined as required by law within 60 days from the date of posting of the Notice of Location. The work of location consisted of making the claim map as provided in N.R.S. § 517.040.
