AMENDED CERTIFICATE OF LOCATION
LODE MINING CLAIM

This document amends the original certificate of location as filed in Eureka County on November 14, 2007, document number 210981 at Book 466, Page 183, and with the Nevada BLM on November 14, 2007 (NMC968758). This document is being filed to correct the tie to an established public survey monument.

NOTICE IS HEREBY GIVEN that PAMELA S. SCUTT, RICHARD McKAY, and NANCY MINOLETTI, whose mailing address is 2749 MiraBella Circle, Morgan Hill, California 95037, have located the VAN 2 lode mining claim, more particularly described below, on the 7th day of September, 2007.

The claim is approximately 1,500 feet long and 600 feet wide, such that 200 feet are claimed in a S 9° 48' 30" W direction and 1300 feet in a N 9° 48' 30" E direction from the point of discovery (monument of location), at which a Notice of Location was duly posted, together with 300 feet on each side of the monument of location and center line of the claim. The monument of location upon which the Notice of Location was posted is a wood post measuring at least 1½" x 1½" x 4', set one foot in the ground. The general course of the lode or vein is from the Northeasterly to the Southwesterly direction.

The exterior boundaries of the claim are distinctly marked by four wooden posts measuring at least 1½" x 1½" x 4', set one foot in the ground, one at each corner. The boundaries of the claim are described as follows: Beginning at the NE corner of the claim, which is corner No. 1 (marked 2/3 1), from which the SE corner of Section 36, Township 16 North, Range 52 East, MDM bears N 73° 32' 15" E a distance of 13,205 feet:

thence 1500 feet S 9° 48' 30" W to the SE Corner, which is corner No. 2, marked 2/3 1

thence 600 feet N 80° 11' 30" W to the SW Corner, which is corner No. 3, marked 2/3 1

thence 1500 feet N 9° 48' 30" E to the NW Corner, which is corner No. 4, marked 2/3 1

thence 600 feet S 80° 11' 30" E to said corner No. 1, the point of beginning.

The corners were so marked on the posts with black ink, or were marked on a scribed aluminum tag attached to the post.

The claim is located within the: SE¼ of Section 3, Township 15 North, Range 52 East; M.D.B.&M., Eureka County, Nevada.

The boundaries of the claim were defined as required by law within 60 days from the date of posting of the Notice of Location. The work of location consisted of making the claim map as provided in N.R.S. § 517.040.
